For 2022 Promoting Operability reporting, DrChrono provides you with the data you will need in order to report. You can obtain the PI data in DrChrono and enter that information into your Healthmonix MIPSpro dashboard.

Please note: DrChrono does not directly export MIPS data to CMS. A 3rd-party registry is needed. MIPS reporting is performed through our partner [Healthmonix](#).
