

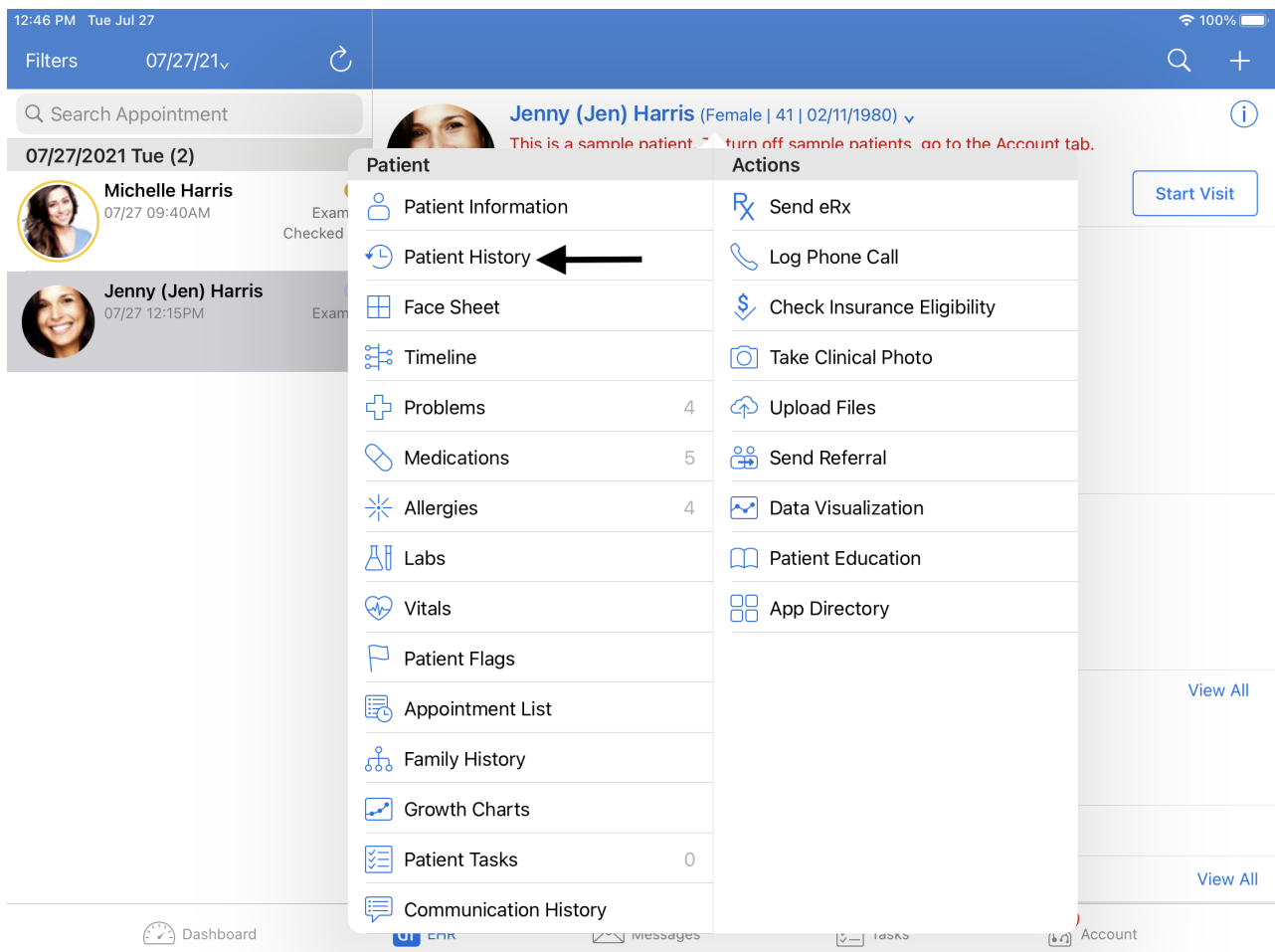
How do I view my patient's history and documents on the iPad?

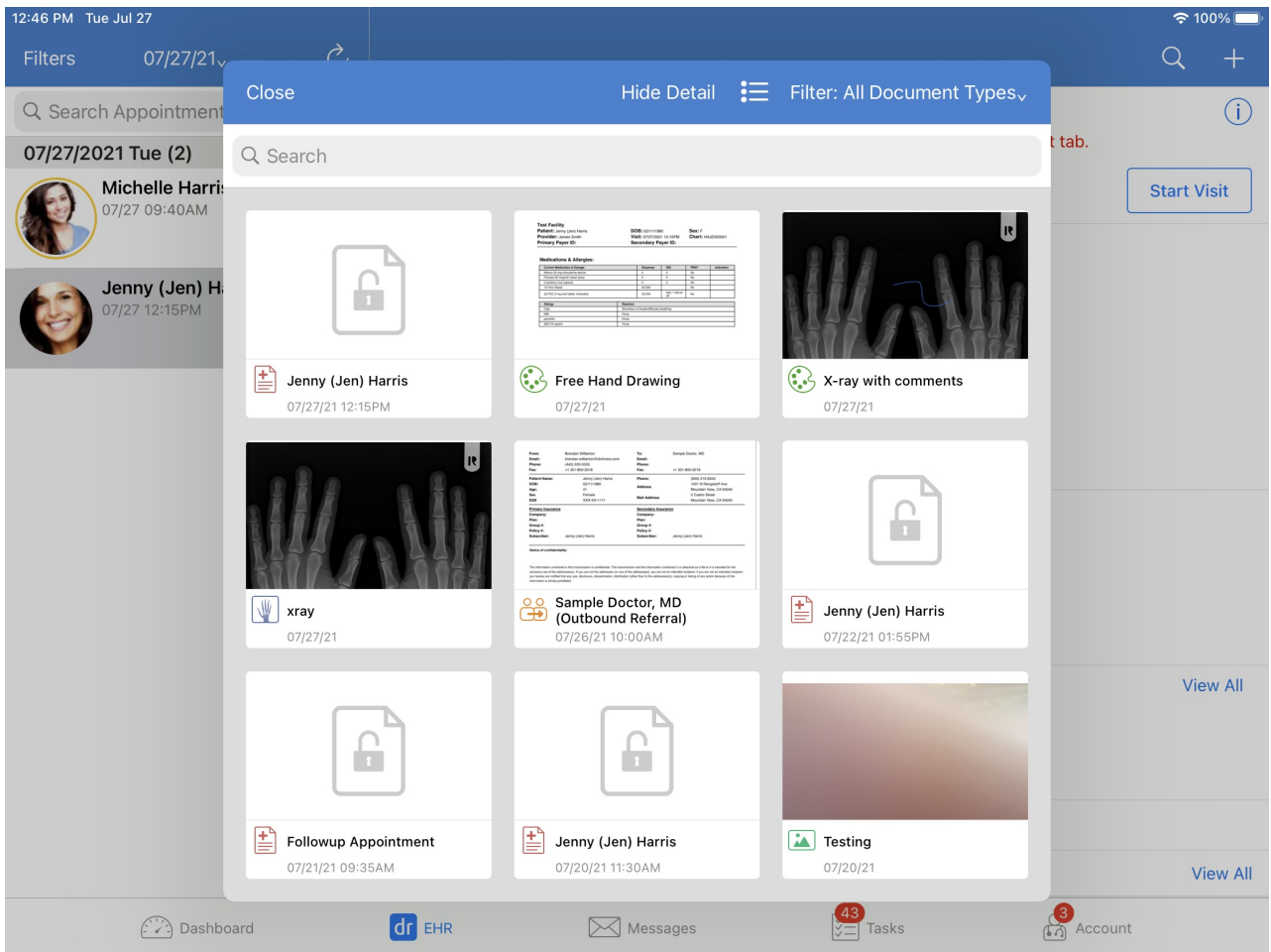
In the [EHR app](#), all your patient's past documentation is accessible with patient history. Within patient history, you can access:

- Past clinical notes
- Patient documents
- Lab results
- Photos
- Imaging
- Videos

To access patient history, navigate to a patient's profile in the EHR section of the app by tapping on the patient's name and selecting **Patient History**.



When you select **Patient History**, you'll be presented with a list of all the patient's documents, clinical notes, lab results, imaging, photos, and videos. By tapping on the **Filter** button, you can select which kind of documents to be shown. You may also switch between icon view and list view.
