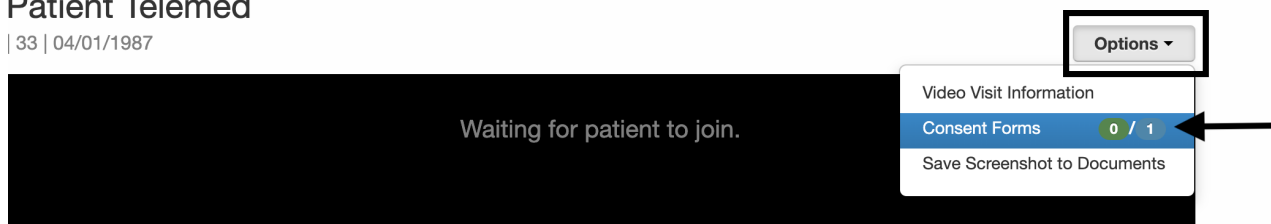

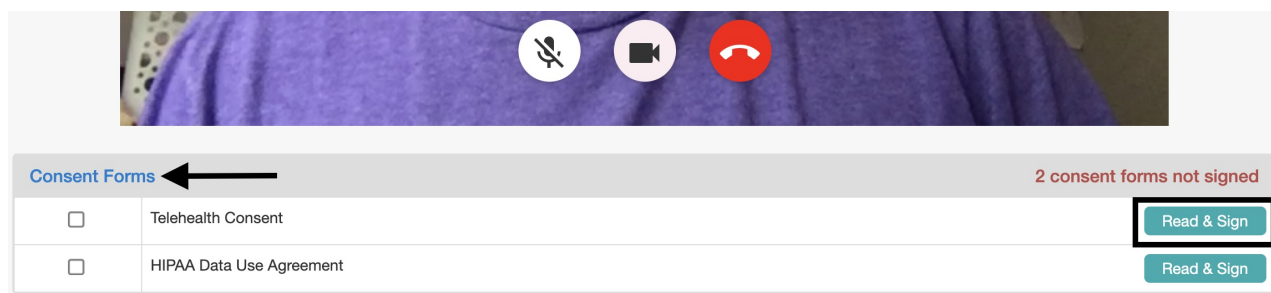

After joining the video visit, the patient can sign consent forms by clicking on **Consent Forms** and selecting **Read & Sign**.



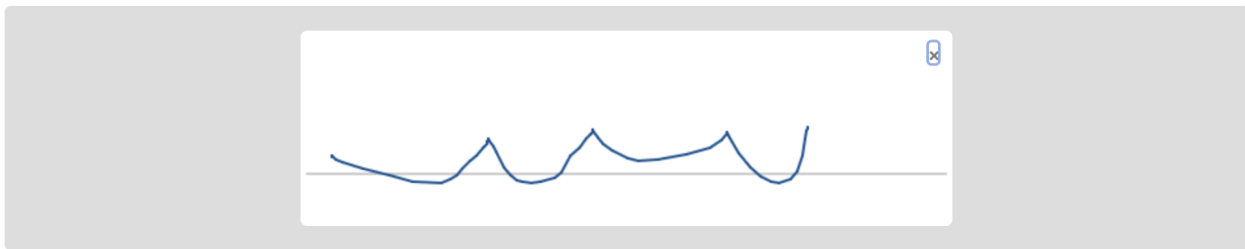
The document will open for the patient to add their signature. By clicking **Save Signature** the document will be signed and saved in the patient's chart under documents.
