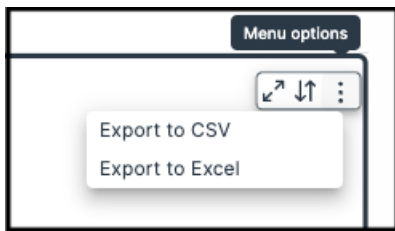


Aging AR Analysis Updates: Export Reporting

Once you have selected your parameters and the report has generated, you have the option to export it in MS Excel or CVS format.

The option to export is on the right of the screen by clicking on the 3 vertical dots. The message will export and be available in your message center.

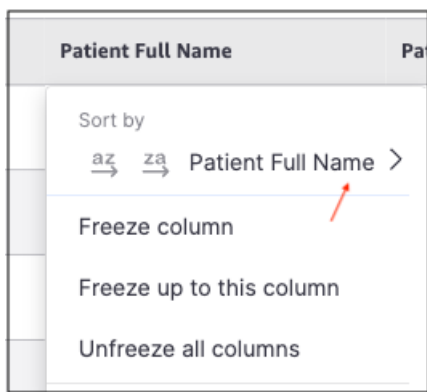
