The following modifications were made to the MIPS Dashboard for 2023 Reporting:</p> <ul style="list-style-type: none"> • All Measures - Scoring, Exclusion and Measurements we updated, as appropriate, to reflect the CMS Promoting Interoperability verbiage for 2023 reporting. • Query of the PDMP Measure: <ul style="list-style-type: none"> ◦ This measure is now a required measure for 2023 reporting. • Provide Patients Electronic Access to their Health Information Automated Measure: <ul style="list-style-type: none"> ◦ Signing a visit note will now send a CCDAs file (for practices configured with the FHIR API's) to the FHIR APIs. 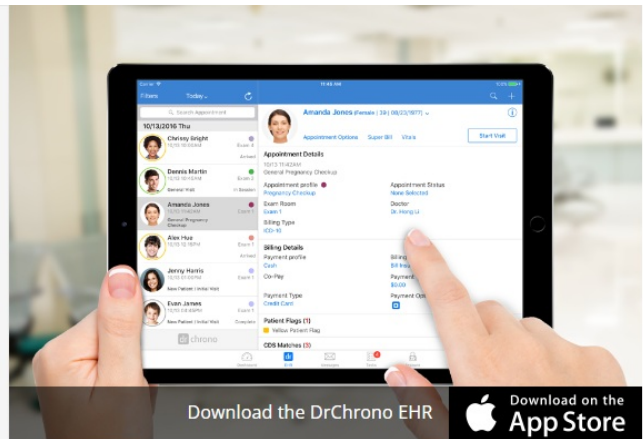
