Sending Multiple EPCS Medications in a Prescription

In DrChrono EHR, it is possible to send multiple EPCS prescriptions. On the New Prescription page, simply select the + button in the upper right-hand corner to add a new medication form to the list.

As you would with any prescription, fill out the form with any combination of schedule II, III, IV, or V medications. For all schedule II drugs, **verify that refills are filled in as '0' due to federal limitations on refilling controlled substances.**
