

# Printing a full or partial ERA

DrChrono now has the ability to print a partial (single claim) or the entire ERA (all claims included on the ERA).

1. Navigate to **Billing > Remittance Reports**
2. Select the ERA that contains the single claim or the entire ERA you would like to print.
3. Under the **Action** pulldown, select **Print Transactions** to print a single claim and **Print ERA(835)** to print the entire file.
