

# 2025 Eligible Clinician eCQMs: Changes Summary

Electronic Clinical Quality Measures (eCQMs) are tools that help healthcare providers track and report on the quality of care they deliver to patients. Each year, the Centers for Medicare & Medicaid Services (CMS) updates these measures to reflect the latest evidence-based practices and healthcare standards.

For the 2025 performance period, there are **47 eligible clinician eCQMs** available for quality reporting, **DrChrono supports 12 of the 47 total measures** The majority of these measures have been updated from their 2024 versions with improvements to measure logic, specifications, or value sets.

### What This Means for Your Practice

**Version updates** indicate that the measure specifications have changed. These changes may include:

- Updated clinical criteria or guidelines
- New or revised value sets (lists of diagnosis or procedure codes)
- Changes to how the measure is calculated
- Updates to the patient population included in the measure

When a measure receives a version update, you should [review](#) the specific changes to understand how they may impact your reporting and quality improvement activities. Even minor updates can affect which patients qualify for the measure or how performance is calculated.
